Brian S. Rosner seeks to build bridges between old and new perspectives on Paul with this biblical-theological account of the apostle's complex relationship with Jewish law. No issue in contemporary Pauline studies is more contested than Paul's view of the law. Headline proponents of the "new perspective" on Paul, such as E.P. Sanders and J.D.G.
