proof of insurance may be accepted by a county treasurer when registering a motor vehicle; however, proof of insurance may not be made by telephone. An applicant for motor vehicle registration must provide proof of insurance in addition to a certificate signed by the applicant. Because county treasurers are county officers and their employees are county employees, generally the county or the county's insurance company would provide for their defense.
